**14. Staff Reports**

A. Office

Chief Lawrence reported that:

- a. The request for the 2023-24 Fire District Sustainability Funding for \$205,006 was submitted to Yolo County. The request will be placed on the Yolo County Board of Supervisor's January 2024 meeting agenda for approval.
- b. He will bring a 2023-24 Budget Revision to the Board once 2023-24 Fire District Sustainability Funding has been approved.
- c. Purchases have been made for the CalFire Grant and he will be submitting the reimbursement request.
- d. The final reimbursement request for \$20,012.46 will be submitted to Yolo County for the Yolo County PO4584 One-Time Grant.
- e. He has determined that the District is not participating in the California State Disability Insurance Program (SDI). He will be researching options for offering short-term disability benefits to employees. This type of coverage, whether with the State or a private insurer, would be an employee-paid benefit.

B. Building & Maintenance Report

Chief Lawrence reported that:

- a. The drainage and lawn projects have been started and are being worked on.
- b. The volunteers will be replacing the kitchen and bathroom floors in the Scout Cabin.
- c. Hose testing was completed.

C. Chief's Report

Chief Lawrence reported:

- a. He has received a few applications for the vacant firefighter position.
- b. He spoke with Capay Valley Fire Protection District's Chief Capitanio and the shared position will be suspended for the month of December 2023.





- c. Reminded the Board that the Volunteer Appreciation Dinner is scheduled for Saturday, December 16, 2023.

CSFA offers several benefits and training opportunities for its members. Paid firefighters must pay \$85.00 per year to be members which the District paid for.
