- a. All rigs have received their annual service; Engine 219 needs a minor repair that will be done next month.
- b. Brush 19's problem, which was under warranty, was worked by Golden State Fire Apparatus, Inc. As Brush 19 is used, he will be able to determine if the problem has been fixed.
- c. The new sleeping quarters are almost finished; and
- d. The contractor for the drainage grading will be on site next week to finish the project.
